# ANNEX 1 to TERMS AND CONDITIONS OF MANAGEDSUPPLIERS.COM (THE AGREEMENT)

# ACCEPTABLE USE POLICY (AUP)

# Introduction

This acceptable use policy (the "AUP") sets out the rules governing:

(a) the use of managedsuppliers.com, any part thereof, any successor website, and the services available on managedsuppliers.com or any successor website ("Services"); and

#### General usage rules

You may use managedsuppliers.com for lawful purposes only.

You agree that when using the managedsuppliers.com or communicating via managedsuppliers.com, you must not use Services or transmit, store or process Content:

- in any way that is unlawful, illegal, fraudulent, deceptive or harmful; or

- constitute a breach of racial or religious hatred or discrimination legislation;
- constitute a breach of any contractual obligation owed to any person.

## Factual accuracy

Content must not be untrue, false, inaccurate or misleading.

Statements of fact contained in Content and relating to persons (legal or natural) must be true.

#### Marketing and spam

You must not without our written permission use the Services for any purpose relating to the marketing, advertising, promotion, sale or supply of any product, service or commercial offering.

Content must not constitute or contain spam, and you must not use the Services to store or transmit spam.

You must not send any spam or other marketing communications to any person using any email address or other contact details made available through the Services or that you find using the Services.
